Counselling sessions, both individual and group, assist students in dealing with emotional challenges and academic pressures.

For Advanced Learners:

Research work, project assignments, and industrial/field visits foster experiential learning. Advanced learners are encouraged to present their ideas in conferences and workshops. Special emphasis is placed on preparing students for competitive exams like UGC-NET and GATE. Practical skill enhancement opportunities are provided through visits to schools and hospitals.

Punjabi University prioritizes the development of 21st-century skills in its students, focusing on innovation, entrepreneurship, and employability. Life skills workshops and orientation sessions are organized to foster these skills. The university constantly updates its curriculum with input from subject experts and industry professionals to ensure students are prepared for the future job market.

Curriculum revisions, project work, assignments, and seminar presentations are key components enhancing students' confidence and collaboration. Research projects and experiential learning opportunities spark interest in innovative research. Departmental clubs and societies allow students to develop organizational and

administrative competence.

The Punjabi Computer Help Centre organizes workshops to enhance students' proficiency in Punjabi typing and online tools for Punjabi language and literature.

The Department of Open and Distance Learning offers a wide array of arts and professional courses, aiming to cater to a large student population. To maintain competitiveness and ensure equivalence with regular courses, internal assessment components are integrated into the programs.

Internal assessment typically accounts for 20 to 40 percent of the total marks for each paper. It includes attendance in Personal Contact Programs (PCPs), assignments, internal tests, viva-voce examinations, and practical files.

For courses like B.A. and M.A. in the arts stream, internal assessment involves PCP attendance, assignments, internal tests, and viva-voce examinations. Professional courses like education,

commerce, computer science, and library and information science also include practical files.

Additionally, PG Diplomas, UG Diplomas, and Certificate Courses follow a similar pattern of assessment, including PCP attendance, assignments, viva-voce examinations, practical files, and internal tests.

The University emphasizes interactive teaching, learning practices, and periodic evaluation to maintain high standards. Course outcome (CO) attainment is tracked to ensure students meet performance targets set by departments or course coordinators, aiming for continuous improvement.

CO assessment involves mapping COs with Program Outcomes (POs) and Program Specific Outcomes (PSOs). Direct assessment tools, including tests, assignments, tutorials, and rubrics, gauge students' knowledge and skills. CO attainment is based on both continuous internal assessment and semester examinations, with a weighting of 30% for internal assessment and 70% for semester exams.

Program Outcome (PO) assessment employs direct and indirect methods, including continuous assessment tests, semester examinations, assignments, lab practicals, and stakeholder surveys. CO-PO mapping aligns course outcomes with broader program objectives.

Students failing CO assessment can apply for re-examination to improve their learning levels. PO attainment is defined at three levels: distinction, first division, pass, and fail, based on average attainment levels and feedback surveys. Toppers receive awards, and students' placements reflect program outcome attainment, such as pharmacy students in manufacturing, regulatory, research, and physiotherapy students in specialized hospitals like orthopedic and neurology units.

3.3 - Innovation Ecosystem

3.3.1 - Institution has created an eco-system for innovations including Incubation centre and other initiatives for creation and transfer of knowledge

The Entrepreneurship, Innovation and Career Hub (EICH) at Punjabi University, Patiala, established under Rashtriya Uchchatar Shiksha Abhiyan (RUSA), aims to create an ecosystem for entrepreneurship and skill development, particularly in rural areas. It focuses on promoting innovation and sustainable entrepreneurship through three verticals: entrepreneurship-centric education, skill development, and incubation.

The Centre for Rural Entrepreneurship and Skill Training (CREST), a part of EICH, facilitates start-ups in rural areas, covering six domains: Agri-food, Medicine, Information Technology, Finance, Physical Sciences, Engineering, and IoT, and Rural Tourism and Artefacts. Key developments under EICH during June 2022-2023 include:

- Approval of the three verticals of EICH by the Syndicate, including Education, Skill Development, and Start-ups, with the incubation center named CREST.
- Approval of six subgroups under EICH, each focusing on specific domains such as Traditional Medicine, Agrifood, and IT, with assigned convenors and members.
- Conducting a workshop on 'Promoting Social Entrepreneurship based Vocational Education' in collaboration with EICH-NSS in November 2022.
- Preparation and release of 27 tenders for major equipment and three turnkey projects under the innovation component of EICH, including the setup of a 3D printing facility and beekeeping

and honey processing units.

- Establishment of a 3D printing facility in the Department of Mechanical Engineering.
- Setup of beekeeping and honey processing units, with the honey processing unit housed in the SIC building.
- Establishment of a state-of-the-art Zebra fish facility in the Department of Pharmaceutical Sciences and Drug Research with 1000 zebra fish.

 - Conducts orientation and training for office staff.

6.4 - Financial Management and Resource Mobilization

6.4.1 - Institutional strategies for mobilisation of funds and the optimal utilisation of resources

Punjabi University, a State University, receives grants from the Punjab Government and funding agencies of the Indian Government for research, academic, and infrastructure activities. Additionally, it generates revenue from student fees, affiliation fees, and exam charges. As per UGC guidelines, the University maintains a fixed deposit of around Rs. 1.13 crores, using the interest for computational infrastructure purchases annually and reinvesting the principal. The Planning and Monitoring Office is allocated Rs. 1.13 crores from this fund.

Over the last five years, the university has secured grants from schemes like PURSE, VAJRA, and SAP. Financial matters are deliberated in the Finance Committee, chaired by the Vice Chancellor and comprising government officials and university representatives. The committee formalizes budgets and expenditures, subject to Syndicate approval.

For unforeseen expenses, the Registrar, with the Finance Officer, makes decisions. Accounts are managed annually, with funds held in

various accounts like Current, Provident Fund, and Endowment Trusts. Property is owned by the university, with the Registrar authorized for financial transactions. The Vice-Chancellor can allocate funds with Syndicate approval, ensuring no recurring liabilities extend beyond the fiscal year. All expenditures require prior approvals and adhere to established procedures, with pre-audits conducted to ensure compliance.

Punjabi University conducts both internal and external financial audits. Until August 2020, the Punjab Government appointed an External Auditor for comprehensive audits, including pre-audits, which were discontinued in September 2020. In September 2020, the Internal Audit Cell was established, conducting audits for three months.

Since November 23, 2020, auditing responsibilities have been divided: the External Audit Cell oversees matters like benefits, promotions, and project audits, while the Internal Audit Cell handles financial expenditures, refunds, and service matters across departments and affiliated entities.

Income statements are regularly audited, and transactions are electronically recorded via e-Office. Audit objections are resolved through adherence to financial rules, proper approvals, purchase procedures, and budget availability. Post and vouching audits are conducted for cash transactions, with in-depth audits for departmental purchases. The accounts branch ensures external audit objections are addressed following proper procedures.

The Women Studies Centre at Punjabi University promotes gender awareness and harmony through academic programs and extracurricular activities. It offers a Master of Arts in Women Studies and a Post Graduate Diploma in Women and Child Development, welcoming both female and male students. The centre organizes seminars, lectures, and cultural events, particularly on International Women's Day, and conducts research on women's issues.

As part of its Gender Sensitization Action Plan, workshops, health camps, and self-defense training are provided to female students university-wide. International conferences on safety and holistic health boost confidence.
